#### The Moment is Here: Transforming Lives with Undocumented Student Resource Centers

Since the enactment of House Bill 3438 on July 1, 2021, public institutions of higher education in Illinois have been mandated to appoint an Undocumented Student Liaison and encouraged to establish Undocumented Student Resource Centers. This legislative stride marks a pivotal moment in advocating for the needs of undocumented and mixed-status family students. In this keynote presentation, Dr. Ellis will discuss the transformative potential of these centers based on recent data gathered from California. Her talk will shed light on how supportive staff and services offered at Undocumented Student Resource Centers positively influence the psychosocial development of undocumented students by alleviating the impacts of undocumented stress cycles. By showcasing the tangible benefits observed in California, Dr. Ellis aims to inspire attendees to envision and champion initiatives tailored to the needs of undocumented students in Illinois.



## Dr. Basia D. Ellis

Dr. Basia D. Ellis is a sociocultural psychologist and immigration scholar who holds the position of Associate Professor at California State University Sacramento. Her research has explored immigrant experiences amidst shifting global politics and immigration laws, with a focus on the lives of undocumented immigrants in Canada and the United States. From a psychological perspective, her work

has traced how undocumented immigrants navigate statusrelated challenges and develop unique forms of selfhood, agency, and well-being in precarious conditions. She also serves as Curriculum Chair for the Dreamer Resource Center on campus, where she actively supports students affected by undocumented status.

#### **1A: Supporting the Mental Health and Well-Being of Students Impacted by Undocumented Status** *Heritage Room*

The goal of this research-informed presentation is to help audience members better understand the experiences of undocumented and mixed-status family college students, as well as identify concrete ways to address these students' practical and psychological needs. In the first part of the presentation, Dr. Ellis will introduce the Undocumented Stress Cycle (USC) as a framework to better understand 'what it is like' to live with undocumented status. The second part of the presentation will build upon this knowledge to identify best practices for supporting students at various stages of the USC. By the end of the presentation, audience members will (a) develop sensitivity to the unique psychosocial experiences and needs of students impacted by undocumented status as well as (b) learn to support these students' agency and capacities for wellness even in challenging conditions.

This presentation explores how having precarious immigration status affects school-involved youth, aged 25 and under in Ontario, Canada. The research focuses on social and academic engagement, academic success, and wellbeing. The research was conducted by University of Toronto (UofT) researchers and the Childhood Arrivals Support and Advocacy Program (CASA). CASA provides legal representation and advocacy for youth with precarious immigration status (YPIS) and helps them develop agency to support safe, secure, and chosen lives. The mixedmethod research project was conducted as a partnership in which CASA clients, CASA staff, and UofT researchers collaborated to design, conduct, and analyze together.

Secondary Trauma, is the emotional stress that comes from hearing about the firsthand trauma experiences of another. Exposure to secondary trauma can impact college attainment. Research suggests that childhood trauma experiences can affect college graduation rates, reducing the likelihood of completion. The pervasiveness of secondary trauma among counselors and supportive professions can lead to negative implications, higher stress levels, and a toxic work environment, which may ultimately impact the support available to students and their educational outcomes. It is important to recognize the impact of secondary trauma and implement trauma-informed approaches in educational settings to support both students and educators.

# 3D: Advocacy, Allyship, and Access: How to be an Undocumented Serving Institution

The Illinois House Bill 3438, known as the Undocumented Student Liasion and Undocumented Student Resource Center, took effect at higher education institutions in the 2022-2023 academic year. While undocumented student liaison positions exist at public two and four-year institutions, we must identify, train, and collaborate across institutions to truly serve the undocumented and mixedstatus students entering Illinois institutions of higher education.

Expanding on Dr. Garcia's Hispanic Serving Institution (HSI) servingness model, this session introduces a new framework: Undocumented and Mixed-Status Student Critical Serving. This new framework weaves together HSI servingness and UndocuCrit (Undocumented Critical Race Theory) to (re)imagine the best practices needed to intentionally serve this increasing student population.

Participants will be informed about the Illinois legislation and some higher education best practices. This interactive session will provide the opportunity to share amongst peers how their institutions are currently serving their students and provide a guide to how to become an Undocumented and Mixed-Status Serving Institution.
